

Thus any proposal for Industrial use on the site will impact that residential community. Staff has proposed to remove it from the PSIC-Bremerton boundary and rezone it as Low Density Residential zoning. Replace page with revised map – it has been included as <b>Exhibit ____-1.</b></p>
