


- All contract and bid documents now contain statements of the City's commitment to equal opportunity in employment and/or contracting.

- Opportunities for employment are also advertised on Diversity Job Board (<u>www.diversityjobboard.com</u>).






















Income demographics

The report provides valuable demographic information related to resident's education, employment (including wage growth and household incomes), household composition, diversity, daily commute habits, and age groups. While not geared toward transportation, it does provide additional valuable data to staff when planning and maintaining City transportation projects and services.

The City continues to contract with Language Line Translation Services, offering interpreting services 24 hours a day, 7 days a week from English to over 240 languages.

Project construction notices (also called door knockers), printed in both English and Spanish, were delivered directly to specific addresses to be affected by the work.

Transportation projects are discussed at a variety of public meetings, including Public Works Committee meetings, City Council study sessions, and City Council Meetings. Announcements for these meetings, as well as project specific meetings, are made via advertisements in the Kitsap Sun, notices on the City's website at www.ci.bremerton.wa.us, and notices sent directly to members of the public who have subscribed, wishing to be notified

The City continues to contract with Language Line Translation Services as an on-call, as needed resource to provide interpreter services in over 240 different languages. This service offers a quick identification of the translation language required. Additionally, the City has bilingual staff available in other departments as a resource.

 - Virtual (online) Project meetings were held in the evenings during 2020, meeting materials were posted on the City's website, and language services are made available; this information is included on all announcements.

 - Language Line Translation Services provided interpretive services for Citywide Activities in Spanish, Arabic, Chuukese, and Tagalog.

The City advertises all of its transportation contracts over \$300,000 on the Kitsap Sun, the City's website, and the Washington State Office of Minority and Women's Business Enterprises (OMWBE). Our Small Works Contract (less than \$300k) rosters are managed by MRSC; all of their legal notices are also posted online with Washington State Office of Minority and Women's Business Enterprises.

b. Identify the DMWBE contracts that were awarded and their dollar amount.

In 2020, DBE Firms were subcontractors on the Kitsap Lake Elementary Safe Routes to Schools Project (DBE Value \$218,010) and the 6th Street Preservation Phase I Project (DBE Value \$100,000).

d. How did your organization ensure that minority, women, and disadvantaged firms were provided equal opportunity to participate in the contracting arena?

The City does not discriminate based on gender or race.

 - All projects in design or construction in 2020 included improvements to pedestrian mobility. No projects were designed or constructed that have a negative impact to any Bremerton citizens.
 - The Kitsap Lake Elementary Project, constructed in 2020, benefits all community members by adding wide sidewalks, speed zone signage, crosswalk markings, rectangular rapid flashing beacons (RRFB), ADA compliant curb ramps, bike lanes, pedestrian lighting, and improved access to the Elementary School. The project is located in an area identified with a high minority (28%) and high non-English speaking (at home) population (15%).

The 6th Street Phase II Preservation Project acquired three Temporary Construction Easements in late 2020. Neither acquisition involved residential property, no language barriers were present, and no concerns affecting disparate populations.
